FURRY FRIENDZY ANIMAL RESCUE FOSTER AGREEMENT CONTRACT

I/we ______(name(s)) fully understand that I/we agree to act as a Foster Home for Furry Friendzy Animal Rescue dog(s). The following conditions apply to fostering for Furry Friendzy Animal Rescue. While in my care and in my home:

- 1. The animal(s) will reside in the house or in a fenced yard on the grounds of the foster home at all times and will remain the property of Furry Friendzy. The animal will be surrendered to an officer or liaison of Furry Friendzy immediately on request.
- 2. The animal(s) will be fed, watered and exercised appropriately. This includes no unsupervised, off-lead exercise time; the animal(s) must be kenneled in a secure, fenced yard. NO SHOCK COLLARS ARE TO BE USED AT ANY TIME. Prong collars are to be used only under the guidance of a trainer. The foster home will not be compensated for expenses incurred in the normal daily care of the animal(s). All Furry Friendzy dogs must receive monthly heartworm preventative unless they are undergoing heartworm treatment. Upon finishing heartworm treatment, Furry Friendzy dog(s) must be started on preventative.
- 3. Veterinary care will be provided by Furry Friendzy. This includes vaccinations, heartworm testing, altering and any prescription medications necessary for the dog. Any expenditure incurred by the foster family other than emergency care and treatment require prior approval by the Furry Friendzy Director (up to \$75). Any expenditure exceeding \$75 will need the Furry Friendzy's Director approval. The foster family will be held responsible for unapproved expenditures.
- 4. Approved veterinary expenses must be submitted with 90 days of the date of the visit to Furry Friendzy for reimbursement. Reimbursement requests should be sent to the following address:

- 5. The animal(s) is/are to be adopted to its permanent home only under the supervision of Furry Friendzy to a family pre-approved by Furry Friendzy.
- 6. The foster family accepts responsibility for any and all events that occur in connection with the fostering of a Furry Friendzy animal(s). The foster family agrees to to release Furry Friendzy from any and all claims, known and unknown, now or hereafter, arising in connection with the animal(s).
- 7. Furry Friendzy requires that the foster family have a crate available should its use be necessary.
- 8. The foster family will evaluate the animal(s) and prepare an evaluation form. The form will be kept with the adoption package as information for the new owners.
